The traineeships are between 2 weeks and 18 months and can take place in any law related area: law firms, courts, public institutions, universities, banks, in-house legal departments, consulting firms and international organisations.

Each year ELSA offers several traineeship opportunities all over Europe and occasionally in other parts of the world.

Before and during the traineeship, ELSA provides assistance in finding accommodation, applying for visas, when necessary and organising social events to involve the trainee in the daily life of the local community.
